Enclose please find an Architectural Control Application for your home improvement or modification. Please note what is needed for <u>your type of improvement</u> and include with your completed and signed application and necessary forms, such as photos, paint samples, drawings, brochures, lot survey, etc. in order for the Architectural Board/Committee members to expedite processing of your application. If these items are not submitted with your application, your request is denied and returned to you for completion. Please read the application carefully.

- ◆ A lot survey is an architectural drawing of your property showing your home, easements and building lines. A copy usually comes with your closing papers.
- Please SHOW on the survey in a distinguishable color other than black ink, the location of your project.
- ◆ Faxed pictures come across as a solid black picture, so please mail or e-mail pictures. Faxed pictures cannot be used.

The completed and signed application should be submitted to Deer Creek HOA by mail or in person to Around the Clock, Inc. 716 W. Meeker St. #101, Kent, WA 98032, or by email to <a href="mailtojennk@aroundtheclockinc.com">jennk@aroundtheclockinc.com</a>.

You will be notified by letter after the ACC committee has made a decision. They have at least 30 days to review and respond to your application.

In an effort to provide and protect each individual homeowner's rights and property values, it is required that any homeowner or group of owners considering improvement(s) and/or change(s) to their home or property submit an "Application for Home Improvements and Modifications" to the Architectural Control Committee. If any change is made that has not been approved, the Association has the right to require the homeowner to remove the improvement(s) and/or change(s) from the property. Approved projects must be completed within 90 days of approval or must be re-submitted.
